### **Grower Information Collection and Consent Form**

GGO and/or Agricorp are collecting the following information for the purpose of populating the system and the geographical information and database management system:

- · Vineyard name, address/location of vineyard;
- Vineyard block information including but not limited to variety, variety clone, rootstock, number of vines, planting year, number of rows, row spacing, vine spacing, information regarding adoption of technologies (e.g. tile drainage spacing and orientation), type of training/trellis system, information relating to conventional production vs. organic production, nursery source, and bud wood source for vines; Detailed GPS information of your vineyard blocks.
- Wind machine Information including but not limited to wind machine brand, engine located direction, fuel type, installation date, hours used at time of data collection, start mechanism, GPS information.

#### The above noted information collected by GGO and/or Agricorp will be used to provide:

- The Grape Growers of Ontario with detailed vineyard, block/variety attribute information for the operations of eGrape.
- Agriculture and Agri-Food Canada (AAFC) and the Ontario Ministry of Agriculture, Food and Rural Affairs (OMAFRA) with
  information in aggregate form (i.e. excluding specific business identifiers) to assist in the development of research, policy,
  marketing initiatives, and new program delivery for the Ontario Grape and Wine sector as a whole, only after consultation with the
  GGO
- Agricorp with producer specific information for the purpose of underwriting, audit and verification for current farm business risk
  programs and services delivered by Agricorp including Production Insurance, AgriStability, and the Self Directed Risk Management
  (SDRM) program.
- Support for other farm business risk management and ad hoc programs and services such as food safety and environmental
  programs now and in the future for the Ontario grape and wine sector.

Agricorp may also use information obtained from you in its underwriting and verification of business risk management programs to verify and correct information in the GGO DMS system. The information collected relates to vineyard/field location and block identification.

If a new purpose arises for the use and/or disclosure of the information, it will be mutually agreed upon by the Grape Growers of Ontario and each grower will be advised prior to any release of grower information.

As a grape grower in Ontario you will have access to any information collected to ensure the accuracy of information collected.
