# Update from your Board Chair



## 2024 Price Negotiations

On Wednesday, July 31st, the Grape Growers of Ontario negotiated a 1-year wine grape (Classes 5-10g) price agreement with Ontario Craft Wineries and Wine Growers Ontario. Under these challenging circumstances, the overall price increased by 1.67% over last year's prices.

Weigh bills are being mailed out to growers on August 9. Please contact the Board office if you require additional weigh bills.

## **Bird Scaring Device Setting**

The use of bird bangers are a normal farm practice but grape growers MUST be vigilant and ensure their equipment is in proper working order. This means sensors, timers and setbacks, volume and frequency are set and monitored correctly. If you are using propane cannons, remember to operate them only when birds are feeding (dawn to dusk) which starts at about 30 minutes before sunrise, and ends about 30 minutes after sunset, when there is enough light for birds to forage.

It is recommended that growers notify neighbours within 175m of your property about when and how your bird bangers will be operated and who to call if there is a problem. Neglect, unnecessary or malicious use for any other purpose will not be tolerated and action from the Normal Farm Practices Board may be taken which could result in the loss of use of bird bangers.

## **Important Information about the Advanced Payments Program (APP)**

Interest-free loans are available to fruit and vegetable farms. Growers who currently don't participate in the Advanced Payments Program are encouraged to have a look at the attached information on the APP loan program, which currently offers up to \$250,000 in interest-free loans to growers of any of a wide range of fruits and vegetables. The slides were presented at OFVGA's webinar about the APP program on June 10th.

A new intake for Ontario's On-Farm Climate Action Fund (OFCAF) opens August 1, 2024, at 9:00 am.

OFCAF provides cost-share funding to farmers to implement best management practices (BMPs) that tackle climate change through reducing emissions of GHGs and supporting increased carbon sequestration. Cost-share support to farmers is available under the project categories of nitrogen management, cover cropping, and rotational grazing.

# Industry Updates Continued

## **Growing Future Opportunities Initiative, Wine Grapes allocated funding at 83%**

The intake period is open, and we implore you to apply for funding. Applications are accepted on a first-come, first-served basis until funding has been fully allocated or the intake period closes, whichever comes first.

Last fall, the Canadian and Ontario governments announced funding of up to \$8 million over 3 years for Ontario apple, tender fruit, table grape, and wine grape growers through the Growing Future Opportunities Initiative under the Sustainable Canadian Agricultural Partnership.

The funding is intended to help growers plant varieties of produce that will improve quality, production, and marketability.

## **Spray Drift Concerns**

OFVGA joined the Grain Farmers of Ontario, Ontario Federation of Agriculture, and CropLife Canada in creating the [Be Drift Aware](#) campaign this year. It was created to raise awareness and promote best practices that will help reduce spray drift in Ontario.

Spray drift issues can be complicated and involve many factors. While the OFVGA does not have resources to be able to follow-up on individual spray drift incidents, they offer the following comments:

- The incident should absolutely be reported to the appropriate authorities. Growers should also do the same with Health Canada's [Voluntary Incident Reporting System](#). The latter is directly linked to PMRA and these are reviewed and considered during re-evaluations and special reviews. Growers should also report this incident to local registrant representatives, agri-retailers, and custom applicators working nearby:
1. Local registrant representatives including Corteva, Bayer, BASF, and Syngenta. It may be possible that the local reps know other cash crop farmers in the area and may help with identifying the issue. At a minimum, it would be a reminder to further educate their local customers on the use of these products and sensitive crops.
  2. Similarly, local agri retailers (e.g. Lakeside Grain & Feed and others) would have nearby cash crop farmers as customers. While they may not get directly involved in this particular incident, it would hopefully at least be a reminder to them to further educate their customers on the use of these products and sensitive crops.
  3. Custom applicators can cover lots of territory but they are equally responsible for the products they are spraying on their customers behalf and should be aware of sensitive crops nearby.

## **Governments Expanding Mental Health Supports for Farm Workers**

The governments of Canada and Ontario are investing up to \$538,000 through the Sustainable Canadian Agricultural Partnership (Sustainable CAP) to expand the Farmer Wellness Initiative to Ontario farm workers. Of that total, nearly \$178,000 will be dedicated to supporting the delivery of services in Spanish.

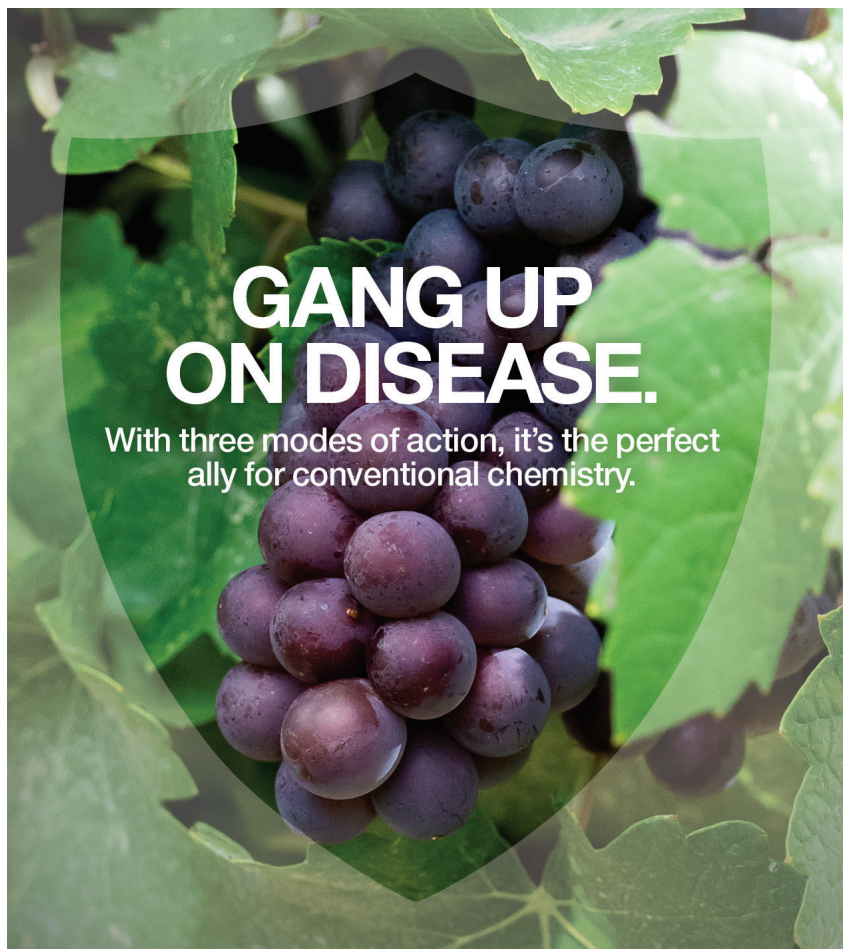
# OGWRI Research Spotlight

CCOVI expedites the production and maintains a repository of virus-free grapevines, bringing the Canadian grape and wine industry another step closer to supplying a sustainable domestic source of clean propagative grapevine material.

Dr. Sudarsana Poojari, Brock University's Principal Scientist in Grapevine Virology has developed meristem shoot tip tissue culture protocols for grape varieties of regional and national importance. This project titled "Development of micro shoot tip culture-based protocols for maintaining virus-free grapevine germplasm for elite and local varieties," was active from January 2022 to March 2024.

The objectives of this project were:

1. Maintain the 50+ virus-free grapevine varieties available through CGCN-RCCV program at the new tissue-culture/phytotron facility at Brock University.
2. Develop meristem shoot tip tissue culture protocols for four cultivars (Pinot noir cl 777, Cabernet franc cl 313, Riesling cl 239 and Chardonnay cl 96) and four rootstocks (SO4, Couderc 3309, Riparia Gloire de Montpellier (RGM), Couderc 161-49, Millardet et de Grasset 101-14) and maintain the virus-free cultures. In addition, we will include prominent rootstocks from non-patented sources into the repository following the CFIA and provincial regulatory guidelines.
3. Develop meristem shoot tip tissue culture protocols for 15 native Ontario riparia rootstock selections.

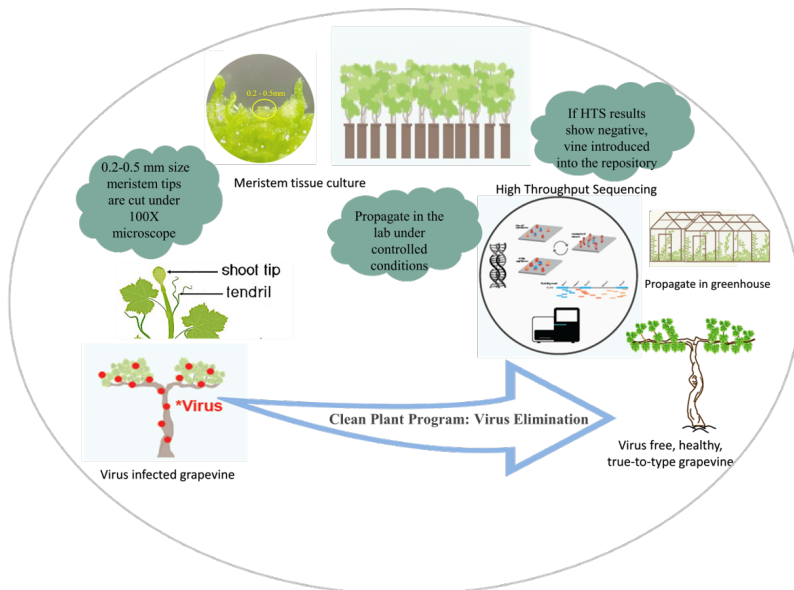

# OGWRI Research Spotlight Continued

As of March 31st, 2024, Dr. Poojari accomplished the following outputs/objectives:

- Standard Operating Procedures (SOPs) were developed for the virus elimination process through meristem tissue culture in grapevines following the screening for viruses using high throughput sequencing technology.
- Standard Operating Procedures (SOPs) were developed for shoot tissue culture to speed up the production of virus-free grapevine.
- A total of 405 grapevine canes representing 50+ varieties are now being maintained in the phytotron at Brock University.
- A total of 114 meristems from 31 grapevine varieties have been cut and are being maintained and grown in the tissue culture lab as part of this project.
- 154 shoots from 51 different grapevine varieties are cut, 100 of them have successfully developed roots and are now under maintenance in the phytotron.
- A new method of micrografting is being developed. A total of 40 grafts have been maintained in the phytotron.



The future of this research will look to enhance the survival rates of both elite and indigenous grapevine varieties by optimizing the growth media and growing conditions. This will be accomplished by experimenting with varying hormone concentrations in the growth media to ascertain the ideal concentration for each specific grapevine variety. Additionally, micrografting protocols will be developed for all 50+ grapevine varieties to improve the quality and production of clean grapevine materials. The success of this project could lead to increased efficiency and productivity in the grapevine industry and advance the scientific understanding of the vine production system.

- New testing requirements for non-CGCN-RCCV sourced G1 material;
- Ability for collaboration amongst CGCN-RCCV participating nurseries;
- Crown Gall designation;
- A list of approved labs for soil nematode testing;
- Approved rootstock sources; and
- Other administrative revisions.

## Is your nursery producing certified vines yet?

Encourage your favorite grapevine nurseries to produce CGCN-RCCV certified material! Until March 31st, 2028, CGCN-RCCV is administering AgriAssurance programming under the Sustainable Canadian Agricultural Partnership (SCAP) which provides CGCN-RCCV participants with up to 50% off virus-testing services and 75% off annual inspections.

CGCN-RCCV recognizes the need for a domestic source of clean grapevine material for replanting initiatives, due to the extreme cold-snap events that took place across Canada over the past few years. The opportunity to start again, to ensure long-term vineyard sustainability against avoidable diseases is to "Start Clean," by planting certified virus tested material, and "Stay Clean," by conducting frequent vector monitoring and properly timed control.

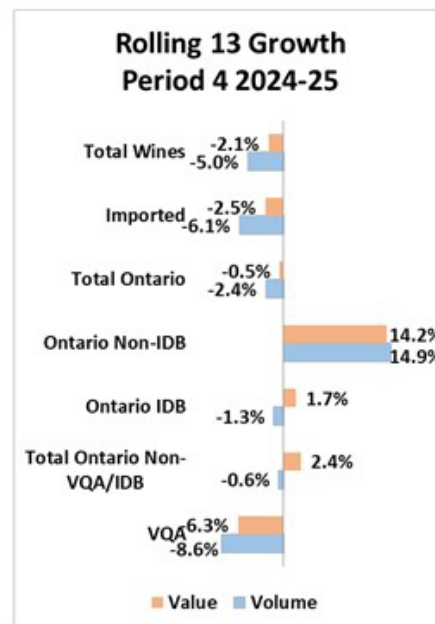
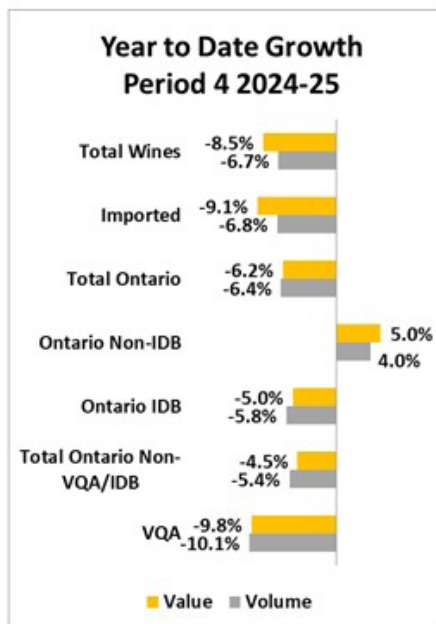
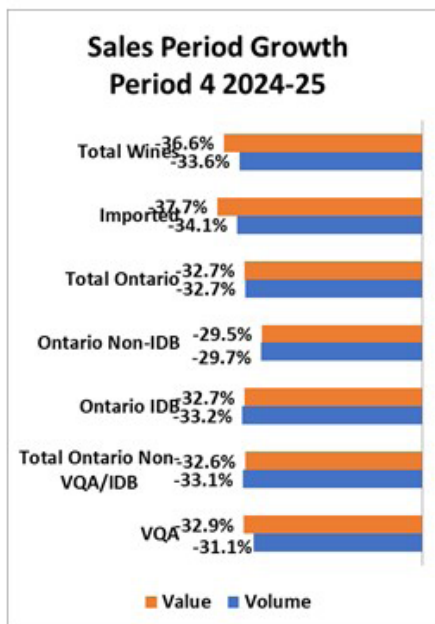

# Wine Sales Update - Period 4

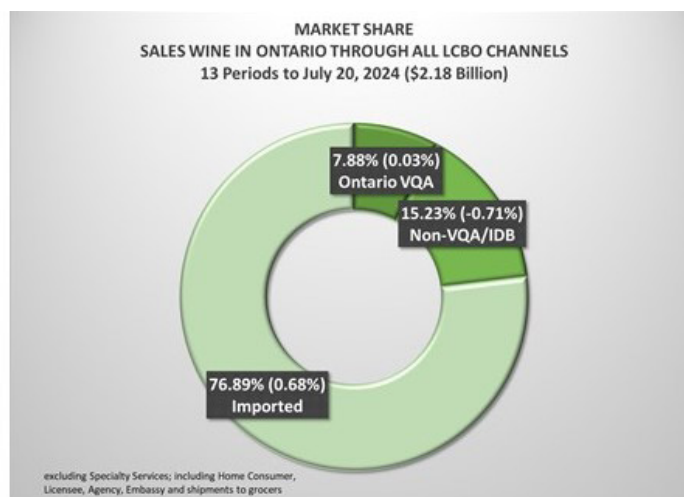
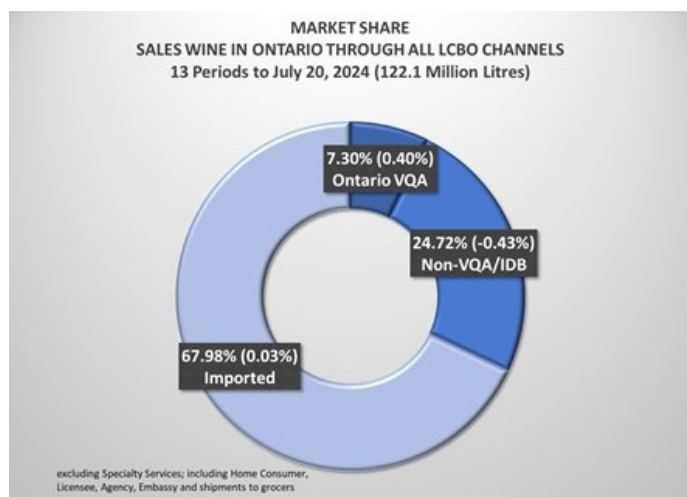

## Highlights:

- VQA wine sales overall are -8.6% for rolling 13 periods (litres)
  - VQA wine sales are down at the LCBO stores (-8.0% litres)
  - VQA wine sales in grocery are declining (-10.9% litres)
- Ontario Non-VQA/IDB is declining (-0.6%)
  - Ontario non-IDB (100% Ontario) is increasing (14.9%)
  - Ontario IDB is down (-1.3%)
